- Any Campership applications received after April 1 will be put into a pool for consideration of any remaining funds.
- **Except** on rare occasions, Camperships are NOT granted for amounts greater than 50% of the camp fee.
- Campership applicants will be notified of award on or around May 1.
- Unit leaders will be advised of Camperships awarded and/or pending, in order to support the camp registration process.  
**Unit leaders will not be provided family's financial information.**
- Campership applicants will make all camp payments to the unit and are advised not to forward final payment to the unit until notice of Campership award has been announced on or around May 1.
- Camperships are awarded for ONE (1) camp session.
- File a separate application for EACH individual requesting a Campership.
- It is understood that this application is not a guarantee that the Scout applicant will be awarded a Campership.
- **ALL INFORMATION MUST BE PROVIDED, INCLUDING ANNUAL INCOME. FAILURE TO COMPLETE APPLICATION WILL CAUSE DELAYS IN PROCESSING.**
